

**FACTS****WHAT DOES CARS AND CREDIT OF JACKSONVILLE DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product of service you have with us. The information can include:

- Social Security number and income
- account balance and payment history
- credit history and credit scores
- Address and contact information
- credit card and other debt
- Employment information

**How?**

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Cars and Credit of Jacksonville chooses to share; and whether you can limit this sharing.

<b>What we do</b>	
<b>How does Cars and Credit of Jacksonville protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Cars and Credit of Jacksonville collect my personal information?</b>	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>• Show your driver's license</li> <li>• apply for financing</li> <li>• give us your income information or provide employment information</li> <li>• provide account information or give us your contact information</li> </ul> <p>We also collect your personal information from other sources, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>• sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>• affiliates from using your information to market to you</li> <li>• sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional right to limit sharing.</p>

<b>Definitions</b>	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• Our affiliates include Cars and Credit of Jacksonville, Inc, Cars and Credit of North Florida, Inc. dba Select Car and Truck Store, Atlantic Finance Company Inc., New Horizons Finance Company Inc., Sunrise Automotive Finance Company Inc., and Auto Maintenance Plus, Inc.</li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• Cars and Credit of Jacksonville, Inc. does not share with nonaffiliates so they can market to you.</li> </ul>
<b>Joint Marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• Cars and Credit of Jacksonville, Inc. doesn't jointly market.</li> </ul>
